

**GATES CORPORATION TO OPEN NEW FACILITY IN VIRGINIA**

Governor Timothy M. Kaine recently announced that Gates Corporation, (<http://www.gates.com/>) the largest non-tire rubber manufacturer of automotive and industrial products, systems and components in North America, will invest approximately \$8 million to open its first Virginia facility in the Highlands Business Park, an industrial park jointly developed by Smyth and Washington counties. The company intends to create 172 new jobs. Virginia successfully competed with Tennessee for the project.

"Gates is an impressive national corporation with international ties, and will be a significant addition to Southwest Virginia," Governor Kaine said. "The company recognized a unique location in Highlands Business Park, and will benefit from the skilled labor force in the area."

Headquartered in Denver, Colorado, Gates Corporation maintains sales and marketing operations in every major automotive market, including North America, Europe, Asia, Australia and South America. Gates is part of the Industrial and Automotive Group of Tomkins plc, a global engineering group listed on both the London (TOMK) and New York (TKS) stock exchanges, and with revenue in excess of \$6 billion in 2006. Tomkins plc has more than 34,000 employees worldwide and enjoys strong market positions and technical leadership, and owns some of the best-known brands in their respective markets.

"Stable economic conditions within the region along with an ideal location to serve our customers drove the decision to locate our operations in the Southwestern Virginia area," said Mike Cottrell, Vice-President North American Hydraulics and Worldwide Technology, Gates Corporation.

"We are excited to have the Gates Corporation choose our community to locate its newest manufacturing facility, and we look forward to the company being a long-term, stable employer for the region," said Kenneth Reynolds, Chairman of the Washington County Board of Supervisors.

"It is great to see the result of the hard work and cooperation of both counties in the regional industrial park. We think that the Gates project will not only create these jobs announced today, but will lead to additional private investment in the park," said Charlie Clark, Chairman of the Smyth County Board of Supervisors.

Gates designs and manufactures V-Belts; timing belts; pulleys; transmission modules; tensioners; and belt drive systems for starters and other components. Their products are manufactured and sold for both the aftermarket and as original equipment.

# BOARD ACTIONS

**Dealer Practices:** An inspection by a MVDB field representative of Nations Auto Group in Alexandria revealed a number of deficiencies related to record keeping; use of dealer tags and temporary tags and failure to display a list of salespersons. In addition, in June and September of 2006 the owner of the dealership was found guilty of a total of seven misdemeanors related to the sale of automobiles. On February 23, 2007, an informal fact-finding conference was conducted to address the alleged violations discovered in the inspection and the convictions. The Board voted to revoke all licenses issued by the Board to Mr. Amanullah Abbasi, owner and to assess a \$6,000 civil penalty.

**Dealer Licensing:** On January 30, 2007, an informal fact-finding conference was conducted for a Richmond area dealer to address allegations that the dealer compensated an unlicensed salesperson and that he was aware that he should not have done so. The Board voted to assess a \$2,100 civil penalty and mandate that the owner successfully complete the dealer-operator course.

In another case, the dealer-operator of the Alexandria area dealership mentioned above under "Dealer Practices" was found guilty of a misdemeanor: selling a vehicle without a title. The Board voted to suspend all licenses issued by the Board for a minimum of sixty (60) days or until the dealer-operator had successfully completed the dealer-operator class, which ever is longer.

# VIRGINIA VEHICLE REGISTRATION FEES INCREASE JULY 1

Registration fees for passenger vehicles and pick up trucks will increase \$10 statewide, beginning with July 1, 2007 registrations. The increases are part of a wide-ranging transportation funding law passed by this year's General Assembly.

For most Virginians, the standard passenger vehicle registration will increase from \$29.50 annually to \$39.50 annually. Passenger vehicles weighing more than four thousand pounds will see a registration increase from \$34.50 to \$44.50.

There are also several increases in registration fees for pick-up trucks and trailers, depending on weight.

Renewal notices for vehicle and trailer registrations scheduled to expire after June 30, 2007 will reflect the new fees. July renewal notices will be received in June rather than May to allow time for computer programming changes. # LICENSING FEES

In the last issue of Dealer Talk there was an article concerning the Board's proposal to adjust the fees that motor vehicle dealers and salespersons are assessed by the Board. The article noted that a Public Hearing had been scheduled to receive comments on the proposed fee schedule. Below is a summary of the meeting:

Bruce Gould called opened the public hearing at 3:10 pm. An attendance sheet was distributed and the following were in attendance:

Gould gave an overview of the regulatory process, noting that the public comment period will end on June 15. He continued by explaining why the Board was pursuing the fee adjustments:

The Motor Vehicle Dealer Board is a Special Fund agency in that it receives no General Fund monies and operates on the fees paid by motor vehicle dealers. The current fee structure was established more than 10 years ago. When the current fee schedule was established, the financial plan was for the Board to build a surplus in revenue in the Special Fund in the first three years and those surplus revenues would cover revenue deficiencies in the last three years of the six year financial plan. A combination of lower than projected expenditures and higher than expected revenues has allowed the Board to stretch its six year plan to nearly 12 years. Without an adjustment to the fee structure, the Board will not be able to continue to provide the quick service that is now being provided to dealers and salespersons.

## DEALER OPERATOR COURSE

Beginning January 1, 2006, the dealer-operator of any new independent motor vehicle dealership will be required to successfully complete a course of study before they will be allowed to take the independent dealer-operator qualification test at any DMV Customer Service Center.

While the Code of Virginia sets the maximum fees the Board may assess, setting the fees must be done through the regulatory process. All dealers and interested parties registered with the Board have been invited to submit comments by mail, email and FAX and have been notified of this meeting and have been sent the following proposed fee adjustments:

License/Certificate	Maximum by Law	Current	Proposed
Dealer-operator Certificate of Qualification	\$50	\$25 to take certification test.	\$50 application fee.
Salesperson Certificate of Qualification	\$50	\$25 to take certification test.	\$50 application fee.
Dealer License	\$300	\$200	\$200
Supplemental License	\$40	\$40	\$40
Salespersons License	\$50	\$20	\$25
Dealer license plates	\$30	\$20 for the first two plates (Two for \$40.) and \$15 for each additional plate.	\$30 for the first two plates (Two for \$60.) and \$26 for each additional plate.

Lastly, the proposed regulations also include technical changes to the "Definitions" section of the regulations in order to make them consistent with recent Code changes.

Gould closed his presentation by restating that the public comment period will end on June 15 and that all public comments will be considered and a final set of regulations will be sent to the Department of Planning and Budget and the Governor's Office for review. It is anticipated that the final regulations will be published in the *Virginia Register of Regulations* around August 20 with a November 1 effective date. All dealers will be notified at least 30 days in advance of the effective date.

Gould then asked if there were any comments, suggestions or questions.

Mr. Charapp recommended that the Board take a close look at legislation [HB 2270] that was passed by the 2007 General Assembly and effective on July 1 that allows licensing of temporary F & I [Finance and Insurance] salespersons to be sure that the revised definition of a salesperson in the regulations and the new legislation are all consistent.

There were no other public comments and the meeting was adjourned.
